

RULES OF USE



1. This park is open for visitors with a minimum height of 125cm and a minimum of 8 years of age. Children from 8-14 years of age are allowed to use the green, blue, red, orange and yellow parcours. Children from 8-10 years of age must be accompanied by an adult at all times. Children and young persons under 15 years of age need a declaration of consent from their legal guardian. Previous experience is not necessary.
2. All visitors must be in a healthy physical and mental state so as not to be a danger to themselves or to others. In case of doubt, please ask our security personnel.
3. Attendance is prohibited to those under the influence of alcohol or drugs.
4. Smoking is strictly prohibited in the whole climbing area.
5. Visitors must not leave the Goruck site wearing safety equipment.
6. Rings and jewellery must be removed. Cameras, mobile phones, drinking bottles etc., which can be dangerous to oneself or to others, must not be carried whilst using the parcours. No liability will be accepted for wardrobe or other items.
7. Long hair must be tied back.
8. The use of the climbing park is at your own risk.
9. The participant acknowledges that injuries such as skin abrasion etc. are possible when using the parcours. Staining from tree resin is possible depending on the season.
10. Safety equipment is fully supplied. Solid shoes such as trekking shoes or trainers together with durable comfortable clothing should be brought along.
11. The safety equipment comprising of a helmet, harness, a safety set with carabiner and reel is not transferable and must be worn at all times.
12. Participation at the safety briefing is compulsory.
13. The partner check (which will be explained during the safety briefing) is compulsory before starting to climb the parcours.

14. An activity may be undertaken by a maximum of one person at a time. A maximum of 2 people may remain on a platform at any one time.
15. The target area must be clear before starting the rope slide / flying fox.
16. Instructions given by the personnel must be complied with exactly and immediately. The management reserves the right to exclude individuals who do not comply with the safety instructions or instructions from the personnel.
17. The management reserves the right to close the operation for safety reasons. (e.g. fire, storm, thunderstorm, etc.)
